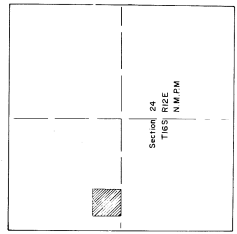
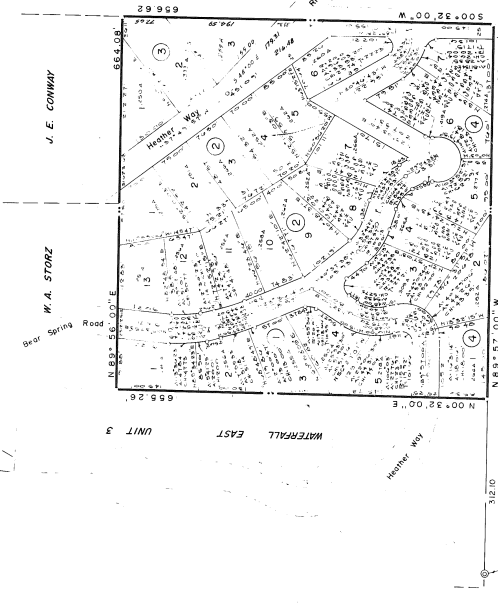


WATERFALL EAST UNIT 4 OTERO COUNTY NEW MEXICO

KNOW ALL MEN BY THESE PRESENTS THAT ZIGMUND E. PISCOTTY, RACHELLE RAE PISCOTTY AND YERINON L.
